## Weekly Testing

Today (Wednesday) and tomorrow, we will begin conducting weekly testing of all residents and staff who have previously tested negative for the COVID-19. This is based on the recommendations of Governor Lamont and the DPH. We will be conducting weekly testing until at least the end of July. Testing will allow us to conduct appropriate cohorting and will aid in managing the spread of the virus.

The results from our weekly testing have come back and I am delighted to report that none of our residents have tested positive! This is the first time we have received a 100% "no COVID" test results. It means our testing, cohorting and infection control measures are working and are proving successful in reducing the spread of the virus at Mary Wade.

# CT Dept. of Public Health

This week we were visiting by the DPH. This is our fifth unannounced survey visit by the DPH to inspect infection control protocols and practices since March. Each of these visits have resulted in a "no deficiencies" report by the surveyors. Our staff, led by Kara Taylor, Director of Clinical Services, and Stan DeCosta, Executive Director are to be commended and recognized for their professionalism and outstanding adherence to the highest standards of care for our residents. Our CNA's, LPN's, RN's, therapists, housekeeping and administrative support team are working hard and doing an amazing job of keeping our residents safe and healthy. They truly are our unsung heroes.

## **Ventilation**

In my May 11 Update I talked about the issue of improved ventilation. Mary Wade is taking a proactive approach in exploring a healthier breathing environment for our residents. Today, we took the first of several steps to improve the ventilation system in the Kimberly Building. The air filters in all of the rooftop units were replaced with high efficiency filters in order to help prevent the spread of bacteria found in the Covid-19 virus, or any other airborne virus such as the seasonal influenza. Additionally, airflow was increased to further improve the filtration process.

## Weekly Testing

We are still receiving results from this week's testing and so far we continue to see no new infections. Any changes, we will be sure to inform you immediately and actions taken.

I am pleased to report that Mary Wade has not had a positive COVID-19 test result of either residents or staff, in more than 14 days. All of our previous COVID cases have fully recovered. Based on the recommended guidelines and Governor Lamont's Executive Order issued on June 17 (*click here* for Executive Order No. 7AAA), we will be reducing our testing to staff only, every other week. Residents will continue to be tested if they display symptom and as always, we will continue to monitory everyone very closely.

## **Balancing Precautions with Social Interaction**

We were recently asked the question "...how is MW going to balance precautions intended to protect staff and residents with the human need for social interaction...?" Great question and it is one of the many that we grapple with since the very beginning of this pandemic. Our practices from the very beginning have been guided by the recommendations and guidelines issued by the Centers of Disease Control (CDC), the Centers for Medicare and Medicaid Services (CMS), and CT's State and municipal Departments of Public Health.

Mary Wade's Therapeutic Recreation staff and our nurses have worked tirelessly to introduce new programs geared to increase social engagement during isolation. Seems a bit contradictory, doesn't it? We've stepped up recreation activities, like "hallway bingo", and waffle carts. With the warmer weather, we have held outdoor concerts for residents. We've conducted continuous video calls with families. We've recently introduced window visits and last week we initiated outdoor family visits dependent upon the weather. This week we started communal dining in Boardman, in two seatings to accommodate for social distancing. We are working with the DPH on developing a similar plan for our Kimberly residents.

All this and more, our staff has creatively and safely initiated to increase social engagement during a time of isolation. It's not ideal, but it has been helpful in improving the health of our residents. We will continue to increase these activities and now that the weather is warming up, we hope to do more outdoor activities and visits to the garden which is always energizing.

We will continue to monitor each and every resident and respond to their needs while keeping them safe. We value and appreciate your cooperation and continued support of these efforts.

We realize that these shields, combined with the mask and the requisite 6 ft social distancing makes it very challenging for many of our residents who are hearing impaired, to enjoy these family visits. Subsequently, we will be reviewing whether to adjust or eliminate this particular face shield protocol.
